

Terms and Conditions

1. About the Website

Welcome to www.rosetterouhana.com. The Website is Rosette Rouhana Arts Therapy. The Website is operated by Rosette Rouhana Arts Therapy (ABN 78 238 582 969). Access to and use of the Website, or any of its associated Products or Services, is provided by Rosette Rouhana Arts Therapy. Please read these terms and conditions (Terms) carefully. By using, browsing and/or reading the Website, this signifies that you have read, understood and agree to be bound by the Terms. If you do not agree with the Terms, you must cease usage of the Website, or any of Services, immediately. Rosette Rouhana Arts Therapy reserves the right to review and change any of the Terms by updating this page at its sole discretion. When Rosette Rouhana Arts Therapy updates the Terms, it will use reasonable endeavours to provide you with notice of updates to the Terms. Any changes to the Terms take immediate effect from the date of their publication. Before you continue, we recommend you keep a copy of the Terms for your records.

2. Acceptance of the Terms

You accept the Terms by remaining on the Website. You may also accept the Terms by clicking to accept or agree to the Terms where this option is made available to you by Rosette Rouhana Arts Therapy in the user interface.

3. Registration to use the Services

As part of the contact or enquiry process, or as part of your continued use of the Services, you may be required to provide personal information about yourself (such as identification or contact details), including:

- (i) Name
- (ii) Email
- (iii) Phone Number

You warrant that any information you give to Rosette Rouhana Arts Therapy in the course of completing the registration process will always be accurate, correct and up to date.

Once you have completed the registration process, you will be a registered member of the Website (Member) and agree to be bound by the Terms.

You may not use the Services and may not accept the Terms if:

- (i) you are not of legal age to form a binding contract with Rosette Rouhana Arts Therapy; or
- (ii) you are a person barred from receiving the Services under the laws of Australia or other countries including the country in which you are resident or from which you use the Services

4. Your obligations as a Member

As a Member, you agree to comply with the following:

- (i) you will use the Services only for purposes that are permitted by:
 - (a) the Terms; and

- (b) any applicable law, regulation or generally accepted practices or guidelines in the relevant jurisdictions;
- (ii) you have the sole responsibility for protecting the confidentiality of your password and/or email address. Use of your password by any other person may result in the immediate cancellation of the Services;
- (iii) any use of your registration information by any other person, or third parties, is strictly prohibited. You agree to immediately notify Rosette Rouhana Arts Therapy of any unauthorised use of your password or email address or any breach of security of which you have become aware;

6. Refund Policy

- (b) Any benefits set out in this Terms and Conditions may apply in addition to consumer's rights under the Australian Consumer Law.

7. Copyright and Intellectual Property

- (a) The Website, the Services and all of the related products of Rosette Rouhana Arts Therapy are subject to copyright. The material on the Website is protected by copyright under the laws of Australia and through international treaties. Unless otherwise indicated, all rights (including copyright) in the Services and compilation of the Website (including but not

- limited to text, graphics, logos, button icons, video images, audio clips, Website code, scripts, design elements and interactive features) or the Services are owned or controlled for these purposes, and are reserved by Rosette Rouhana Arts Therapy or its contributors.
- (b) All trademarks, service marks and trade names are owned, registered and/or licensed by Rosette Rouhana Arts Therapy, who grants to you a worldwide, non-exclusive, royalty-free, revocable license whilst you are a Member to:
 - (i) use the Website pursuant to the Terms;
 - (ii) copy and store the Website and the material contained in the Website in your device's cache memory; and
 - (iii) print pages from the Website for your own personal and non-commercial use.
 - (c) Rosette Rouhana Arts Therapy does not grant you any other rights whatsoever in relation to the Website or the Services. All other rights are expressly reserved by Rosette Rouhana Arts Therapy.

 - (i) all terms, guarantees, warranties, representations or conditions which are not expressly stated in the Terms are excluded; and
 - (ii) Rosette Rouhana Arts Therapy will not be liable for any special, indirect or consequential loss or damage (unless such loss or damage is reasonably foreseeable resulting from our failure to meet an applicable Consumer Guarantee), loss of profit or opportunity, or damage to goodwill arising out of or in connection with the Services or these Terms (including as a result of not being

able to use the Services or the late supply of the Services), whether at common law, under contract, tort (including negligence), in equity, pursuant to statute or otherwise.

- (c) Use of the Website and the Services is at your own risk. Everything on the Website and the Services is provided to you "as is" and "as available" without warranty or condition of any kind. 10. Limitation of liability

11. Competitors

If you are in the business of providing similar Services for the purpose of providing them to users for a commercial gain, whether business users or domestic users, then you are a competitor of Rosette Rouhana Arts Therapy. 12. Termination of Contract

- (a) The Terms will continue to apply until terminated by either you or by Rosette Rouhana Arts Therapy as set out below.

- (b) If you want to terminate the Terms, you may do so by:
 - (i) providing Rosette Rouhana Arts Therapy with 28 days' notice of your intention to terminate; and
 - (ii) closing your accounts for all of the services which you use, where Rosette Rouhana Arts Therapy has made this option available to you.

Your notice should be sent, in writing, to Rosette Rouhana Arts Therapy via the 'Contact' link on our homepage.

- (c) Rosette Rouhana Arts Therapy may at any time, terminate the Terms with you if:
 - (i) you have breached any provision of the Terms or intend to breach any provision; Rosette Rouhana Arts Therapy is required to do so by law;
 - (ii) the provision of the Services to you by Rosette Rouhana Arts Therapy is, in the opinion Rosette Rouhana Arts Therapy, no longer commercially viable.
- (d) Subject to local applicable laws, Rosette Rouhana Arts Therapy reserves the right to discontinue or cancel your membership at any time and may suspend or deny, in its sole discretion, your access to all or any portion of the Website or the Services without notice if you breach any provision of the Terms or any applicable law or if your conduct impacts Rosette Rouhana Arts Therapy's name or reputation or violates the rights of those of another party.

13. Indemnity

You agree to indemnify Rosette Rouhana Arts Therapy, its affiliates, employees, agents, contributors, third party content providers and licensors from and against:

- (a) all actions, suits, claims, demands, liabilities, costs, expenses, loss and damage (including legal fees on a full indemnity basis) incurred, suffered or arising out of or in connection with your content;
- (b) any direct or indirect consequences of you accessing, using or transacting on the Website or attempts to do so; and/or
- (c) any breach of the Terms.

14. Dispute Resolution

14.1 Compulsory:

If a dispute arises out of or relates to the Terms, either party may not commence any Tribunal or Court proceedings in relation to the dispute, unless the following clauses have been complied with (except where urgent interlocutory relief is sought).

14.2 Notice:

A party to the Terms claiming a dispute (Dispute) has arisen under the Terms, must give written notice to the other party detailing the nature of the dispute, the desired outcome and the action required to settle the Dispute.

14.3 Resolution:

On receipt of that notice (Notice) by that other party, the parties to the Terms (Parties) must:

- (a) Within 28 days of the Notice endeavour in good faith to resolve the Dispute expeditiously by negotiation or such other means upon which they may mutually agree;
- (b) If for any reason whatsoever, 28 days after the date of the Notice, the Dispute has not been resolved, the Parties must either agree upon selection of a mediator or request that

an appropriate mediator be appointed by the A mediation body can be used to assist the parties to come to a mutual agreement through non-judicial means. Here is a list of accredited mediation bodies in Australia - msb.org.au/msb-member-list. Common choices include the Australian Mediation Association and the Resolution Institute.;

- (c) The Parties are equally liable for the fees and reasonable expenses of a mediator and the cost of the venue of the mediation and without limiting the foregoing undertake to pay any amounts requested by the mediator as a precondition to the mediation commencing. The Parties must each pay their own costs associated with the mediation;
- (d) The mediation will be held in Sydney, Australia.

14.4 Confidential

All communications concerning negotiations made by the Parties arising out of and in connection with this dispute resolution clause are confidential and to the extent possible, must be treated as "without prejudice" negotiations for the purpose of applicable laws of evidence.

14.5 Termination of Mediation:

If 2 months have elapsed after the start of a mediation of the Dispute and the Dispute has not been resolved, either Party may ask the mediator to terminate the mediation and the mediator must do so.

15. Venue and Jurisdiction

The Services offered by Rosette Rouhana Arts Therapy is intended to be viewed by residents of Australia. In the event of any dispute arising out of or in relation to the Website, you agree that the exclusive venue for resolving any dispute shall be in the courts of New South Wales, Australia.

16. Governing Law

The Terms are governed by the laws of New South Wales, Australia. Any dispute, controversy, proceeding or claim of whatever nature arising out of or in any way relating to the Terms and the rights created hereby shall be governed, interpreted and construed by, under and pursuant to the laws of New South Wales, Australia, without reference to conflict of law principles, notwithstanding mandatory rules. The validity of this governing law clause is not contested. The Terms shall be binding to the benefit of the parties hereto and their successors and assigns.

17. Severance

If any part of these Terms is found to be void or unenforceable by a Court of competent jurisdiction, that part shall be severed and the rest of the Terms shall remain in force.
